

# Licence to publish

The **Journal** is an open access journal which operates under a Creative Commons Licence Deed (*Attribution-NonCommercial-ShareAlike 4.0 International*).

This document (the **Licence to Publish**) sets out the terms and conditions upon which the Author/s provide the Work to the Sax Institute for use and publication in the Journal. The licence agreement assists with the protection of copyright material and permits the Sax Institute to respond to third party requests in relation to the copyright material.

Please read this document carefully and fill in the required information. By submitting the Work and a signed copy of this Licence to Publish, the Author/s agree to the terms and conditions listed below.

## 1. Warranty

The Author/s warrant that they own the copyright in the Work, and that the Work:

- (a) Has not been published before and is not being considered for publication elsewhere
- (b) Does not violate any intellectual property rights of any third party, contain any defamatory content, or contain any matter that contravenes any Australian Commonwealth, State or Territory law (this includes any images, tables, graphs or figures accompanying the Work)
- (d) Meets the ethical standards of the relevant research discipline.

## 2. Licence

The Author/s grant to the Sax Institute an irrevocable exclusive worldwide licence to:

- (a) Reproduce, publish or communicate the Work to the public for any purpose
